This warranty is the only warranty made by the Company and can be amended only by a written document signed by the manager of the Company. Continued use or possession of the product after expiration of the applicable warranty period stated above shall be conclusive evidence that the warranty is fulfilled to the full satisfaction of Buyer.

The Company makes NO WARRANTY, express or implied, as to products or software supplied by or purchased from third parties. To the extent permitted by the Company's contract or license with the third-party supplier or seller, the Company shall assign to Buyer any warranties provided to the Company with respect to such product or software.

The Company's sole obligation and liability under this limited warranty shall be to use reasonable efforts to remedy any substantial non-conformance that is reported to the Company in writing within the applicable warranty period. In the Company's sole discretion, such remedy may be to repair or replace the product or to credit Buyer's account for any products that are returned by Buyer during the applicable warranty period set forth above, provided that (a) the Company is promptly notified in writing with a detailed explanation of any alleged deficiencies, (b) the goods are returned F.O.B. Company headquarters in Boulder, Colorado, and (c) the Company's examination of the goods shall disclose that such deficiencies were not caused by accident, misuse, neglect, alteration, improper installation, unauthorized repair or improper testing of the product. If the product fails to conform to the limited warranty provided herein, the Company shall reimburse Buyer for the transportation charges paid by Buyer for returning the product to the Company. If the Company elects to repair or replace the product, the Company shall have a reasonable time to make the repair(s) or replacement. Such repair, replacement or credit shall constitute fulfillment of all obligation of the Company to Buyer under this limited warranty, whether Buyer's claim is based in contract, tort, or indemnity, on a statutory provision or otherwise.
